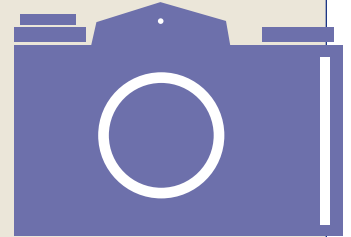

- Focus on people interacting or in action, rather than formal portraits.
- Have the subject fill the frame; try to get as close as possible.
- When photographing events with speakers, avoid shooting from the back of the room (too many backs of heads).
- Select camera settings for high-quality, large images.
